




Inflation Expectations are Moderating




Mortgage Risk Premium Very High




NAR Mortgage Rate Forecast




Wichita Home Sales Activity




Active Listings are Rising, but Not Enough to Matter




Inventories Still Below What is Needed for a Balanced Market




Homes are Still Selling Very Quickly




Typically at or Above Original Asking Price






Home Price Appreciation is Slowing but Remains Strong




Home Price Appreciation Forecast




The Rebound in Single-Family Construction has Stalled
